Terms & Conditions for the supply of (Furniture Items) :

1. All charges payable by the University should clearly be stated
2. The E-tender should be submitted only if the material is available in your stock or can be supplied within **30 Days** after the order is placed.
3. The E-tender should be uploaded by **25.03.2019** upto **5:00 P.M.** on <http://etender.hry.nic.in> and www.cblu.ac.in
4. E-tenders will be opened on **26.03.2019** at **12:30 P.M.** in the Computer Centre, **Chaudhary Bansi Lal University, Bhiwani, (Haryana)** by the Purchase Committee in the presence of the parties or their representatives whosoever may like to be present.
5. Every tender shall be accompanied by an earnest money @ 2% of the total cost of material of the quoted rates in the shape of bank drafts in favour of Finance Officer, Chaudhary Bansi Lal University, Bhiwani payable at State Bank of India, Bhiwani.
6. E-tender fee of Rs. 1000/- in the shape of Bank draft in favour of Finance Officer, Chaudhary Bansi Lal University, Bhiwani payable at State Bank of India, Bhiwani is required.
7. The E-tenders received without earnest money or tender fee shall not be entertained.
8. **E-tenders may be uploaded for supply of Furniture Items.**
9. The goods shall be supplied by the supplier within the time limit specified in the supply order. **In case, the material is not supplied within the delivery period the supplier shall be liable to pay the University the compensation amount equivalent to 1% of the cost of material per day or such other amount as the Registrar may decide till the supply remains incomplete, provided that the total amount of compensation shall not exceed 10% of the total amount of the cost of material supplied/to be supplied.** Appeal against these orders shall, however, lie with the Vice-Chancellor, Chaudhary Bansi Lal University, Bhiwani whose decision shall be final.
10. In case, the contractor backs out of the contract, the earnest money deposited by the contractor shall be forfeited besides taking any other action as may be considered necessary by the Vice-Chancellor.
11. The quantity of the material shall be subject to increase or decrease on the tender rates. The acceptance of goods is subject to the approval of the Inspection Committee.
12. If yours rates are approved by the GEM and other Central/State Agency, the same must be quoted and the copy of the rate contract be attached.
13. Rates be quoted F.O.R. CBLU, Bhiwani.
14. 100% payment will be made on receipt and inspection of goods after installation to ensure the specifications and their good condition.
15. The offer must be valid for a period of at least 3 months from the date of opening of tender.
16. The Registrar reserves the right to reject or accept any or all offers without assigning any reason.
