NOTIFICATION

The Vice-Chancellor has been pleased to approved the following criteria for 20% Internal Marks in Ph.D. Course in anticipation approval of the Academic Council: -

1. For the papers like research methodology and advance level course preparing the student for research in concerned subject or wherein applicable, the marks awarded to a student by the concerned teacher(s) in any particular paper will be based on performance of student in minor test/ assignment/ presentation. The distribution of the weightage for 20 marks will be as under:

Minor Test/ Assignment/ Presentation	15 Marks
Attendance	5 Marks

Marks of attendance will be given as under:

i). 85% onwards	05 Marks
ii). 80% to less than 85%	04 Marks
iii). 75% to less than 80%	03 Marks
iv). 65% to less than 75%	02 Marks*

*For students engaged in co-curricular activities of the Departments/ authenticated medical grounds/ under circumstances beyond the control of student to the satisfaction of the concerned Chairperson/Head/In-charge on valid documentary proof.

2. For review of literature paper, 20 marks, wherein applicable, will be awarded to student on the basis of presentation and write up. The distribution of the weightage for 20 marks will be as under:

Presentation	10 Marks
Write Up	10 Marks

A committee of the following shall assess internal assessment of the paper of review of literature:

1. Chairperson/Head/In-charge of Department
2. At least two teachers from the department who are teaching the course.

Provided further that if a candidate remains absent in the minor test/ presentation, he/she will have to apply within 10 days from the date of conduct of the test to the Chairperson/Head/In-charge of the concerned department and if found genuine, the Chairperson/Head/In-charge of the department will allow the candidate to appear in minor test/ presentation. However, the candidate will then be required to deposit a fee of Rs. 1000/-. No, further chance will be given in any circumstances.
