NOTIFICATION

In pursuance of the order of the Director General Higher Education, Haryana, issued vide Memo No. DHE-010019/5/2020-Coordination-DHE, dated Panchkula 30.04.2021 regarding SOP for closure of Colleges and Universities, it is hereby notified that all the University Teaching Departments will remain closed till 31.05.2021 for all the students. However, online teaching and other online activities will continue.

The teaching and non-teaching employees will continue to attend their departments/offices provided they are asymptomatic and by strict adherence of COVID-19 generic preventive measures.

In Continuation of office order No. CBLU/Gen-129/2021/718-760 dated 26-04-2021, it has been observed that large number of corona positive cases have been reported in various branches/departments in the recent time which is expected to increase further view of rapid Covid-19 test programme. In view of health & safety of the employees, the Vice-Chancellor has been pleased to approve the following preventive measures to be taken by the Offices/Departments etc. upto 31.05.2021

1. All the HOD/Chairperson/In-charges of teaching & non-teaching departments/branches shall remain in touch with the members of their respective departments/branches online.
2. All the HOD/Chairperson/In-charges of teaching & non-teaching departments/branches are requested to decide the 50% of physical attendance of the non-teaching staff.
3. Roster of the teaching staff to be decided by the concerned HOD as per requirement.
4. All Meetings to be conducted through online mode.
5. All official who attend office shall strictly follow Covid-19 appropriate behaviour including wearing of mask, physical distancing, use of sanitizer and frequent hand washing with soap and water.
6. Entry of outsiders/visitors to be prohibited.
7. Essential services like Electricity and Internet Connectivity, cleaning and Security shall be taken care of by respective branches.

All the HOD/In-charges/Branch Officers (teaching & non-teaching) are requested to comply the above instructions in their respective departments/branch.
