The fees need to be deposited within the time frame mentioned above and one copy of the fee receipt must be submitted to the department on or before 23-06-2026.
- The candidature/merit of the candidate may be affected in case of failure of candidate to produce documents during physical verification in support of claim made by him/her in application form.
- If a candidate does not appear physically for counseling then his/her claims for admission to next counselling will be cancelled. However, he/she may appear for Physical Counselling/Open Counselling if seats remain vacant.
