GUIDELINES FOR PHYSICAL COUNSELLING FOR ADMISSIONS IN POSTGRADUATE PROGRAMMES BEING RUN BY THE UNIVERSITY TEACHING DEPARTMENTS FOR THE ACADEMIC SESSION 2026-27

In continuation of the ongoing admission process for the Academic Session 2026-27, the University has decided to conduct **Physical Counselling** for admission to Postgraduate Programmes being run by the University Teaching Departments. The guidelines for the same are as under:

1. **Date and Time of Counselling:** Physical counselling shall be held on **22.07.2026** in the respective Departments as per the prescribed rules. All eligible candidates are required to appear **in person** and mark their attendance by signing in the attendance register between **9:00 A.M. to 12:00 Noon**.
2. **Eligibility of Previously Registered Candidates:** Candidates who had registered earlier within the prescribed time but could not take admission during the **First, Second, or Third Counselling** due to any reason(s), be eligible to participate in the physical counselling.
3. **Reporting Deadline:** No candidate shall be allowed to mark attendance after **12:00 Noon**. However, candidate may allow after 12:00 Noon if seats are vacant upto 04:00 PM.
4. **Preparation of Merit List:** The merit list of the candidates who mark their attendance shall be prepared strictly as per the **Reservation Policy** of the University/State Government and will be displayed on the Notice Board of the concerned Department as well as on the University website.
5. **Eligibility Conditions and Seat Matrix:** The minimum eligibility conditions and the number of seats for admission to various programmes shall remain the same as notified in the **Admission Information Brochure 2026-27**. Candidates are advised to visit the University website regularly for updates, if any.
6. **Supernumerary Seats:** All supernumerary seats being offered by the Departments shall also be filled through physical counselling on **22.07.2026**. Candidates seeking admission under such categories must mark their attendance in the concerned Department between **9:00 A.M. to 12:00 Noon**.
7. **Verification of Documents:** Candidates must produce all original documents related to educational qualifications, category certificate (if applicable), income certificate (if applicable), weightage, Character, Aadhar Card, Family Card, Migration Certificate, if available now and other claims at the time of counselling. Failure to produce the required documents in original shall result in cancellation of candidature. The candidates are also required to bring 2 Sets of Photocopy of all documents and 6 Photographs.

8. **Admission under BC-A and BC-B Categories:** Admissions under **BC-A** and **BC-B** categories shall be made in accordance with the provisions mentioned in the Admission Information Brochure. In case seats remain vacant in either sub-category, the same shall be interchanged and filled from the other sub-category strictly on merit basis. For example, vacant seats in **BC-B** may be filled from **BC-A** candidates and vice versa.
9. **Fee Submission:** Candidates admitted through physical counselling must deposit the prescribed admission fee on or before **23.07.2026**, failing which their admission shall stand cancelled automatically.
