The University invites **Expressions of Interest (EOI)** from distinguished and emerging **Artist/Artisan-in-Residence** in diverse art forms (Dance(Classical/Folk), Theatre, Visual Arts, Fine Arts, Ordinary Skills, Music, Literary Skills) for **appointment as Artist/Artisan-in-Residence** under the *UGC Guidelines for Empanelment of Artists/Artisans-in-Residence in Higher Educational Institutions*.

1. EMPANELMENT OF THE KALA GURU (ARTIST/ARTISAN) IN RESIDENCE

Criteria for Empanelment: The received applications will be scrutinized by the Committee consisting of Dean, Student Welfare and 02 Senior HoDs of the University. The same should be evaluated by the Committee which will submit its recommendations to the Competent Authority for empanelment of Kala Guru's Artists/ Artisans – in – Residence.

Structure of the Committee for Empanelment:

- I) Head of the Institution or his nominee (Chair).
- II) Head/Coordinator of the concerned Department(s)/Activities.
- III) Two External Experts of the relevant discipline (nominated by the head of the institution)
- IV) Registrar / Vice-Principal or equivalent person (Convener).

Tenure of Engagement: The empanelled Artist-in-Residence shall be appointed for 1 year, which is extendable as per recommendation of the committee.

Level-I: Guru (Artist/Artisan)

Level-II: Param Guru (Outstanding Artist/Artisan)

Level-III: Parameshti Guru (Eminent Artist/Artisan)

2. ELIGIBILITY

PARAMESHTHI GURU

Padma Awardee or a prestigious honour of National or International Level

- No age limit
- The experience in the field of expertise should not be less than 20 years

PARAM GURU

At least one National and State level Government recognized award or any other award of the equivalent level

- No age limit
 - The experience in the Field of expertise should not be less than 10 years
- Artists/Artisans approved by the Prasara Bharati for the dance and theatre.

GURU

Those Artists/Artisans, who do not come in the above categories, but have gained fame as master artist of a particular Art form.

- No age limit
- The experience in the field of expertise should not be less than 05 years.

Essential Eligibility:

Participation in 05 International/National/Government recognized/sponsored concerts or at least

05 International and National Exhibitions, Art fairs, Workshops etc. Kala Guru, who come from the traditional family (Gharana) of an art form, their candidature must be supported by the proof of the fame of the Artist's lineage.

3. WORK-PLACE FACILITIES AND HONORARIUM

Studio/work place

The empanelled Kala Gurus will be provided suitable well-equipped workplace to carry out the activities having requisite facilities and materials along with other assistance needed to deliver the learning.

3.1 Travel Expenses and Accommodation

The empowered Kala Guru will be provided TA/DA/Accommodation etc, as per the norms of HEIs.

3.2 Remuneration: As per University norms

4. ROLES AND RESPONSIBILITIES

They may hold lectures, demonstrations, workshops, practicals, trainings, etc

5. How to Apply

Interested Artists/Artisans may submit the prescribed Proforma (**Annexure-A**) along with supporting documents (bio-data, proof of recognition/awards, and lineage proof if applicable) and Certificate to be issued/signed by the employer (**Annexure-B**) on the below address or by mail.

- This is a Rolling EOI and online applications can be submitted throughout the year. Candidates will be allowed to update their qualification, experience and other credentials in the online application portal throughout. Applications will be entertained as per need arising at any time of the year. The University may held interaction with the Artists as per need.
