- The fees can be deposited only after successful physical verification of all documents establishing eligibility to this course and weightage claims made by candidate. The fees need to be deposited within the time frame mentioned above and one copy of the fee receipt must be submitted to the department on or before 17-07-2026.
- The candidature/merit of the candidate may be affected in case of failure of candidate to produce documents during physical verification in support of claim made by him/her in application form.
- If a candidate does not appear physically for counseling then his/her claims for admission to next counselling will be cancelled. However, he/she may appear for Physical Counselling/Open Counselling if seats remain vacant.
