2. The final merit has been prepared based on the percentage of the marks obtained in the Entrance Test.
3. The confirmation of admission to this course is subject to Physical verification of all essential and supporting documents in original (including weightage claims if any) by the admission committee as per schedule mentioned above. Soft copy of the documents will not be accepted for verification. Candidates also need to submit two sets self-attested photocopies of documents including photo IDs if admitted to the course.
4. Candidates are also required to bring any valid Photo Identity card.
5. The fees can be deposited only after successful physical verification of all documents establishing eligibility to this course and weightage claims made by candidate. The fees need to be deposited within the time frame mentioned above and one copy of the fee receipt must be submitted to the department on or before 07-08-2026.
6. The candidature/merit of the candidate may be affected in case of failure of candidate to produce documents during physical verification in support of claim made by him/her in application form.
7. If a candidate does not appear physically for counseling then his/her claims for admission to next counselling will be cancelled. However, he/she may appear for Physical Counselling/Open Counselling if seats remain vacant.
